A pre-proposal meeting will be held on December 30, (Monday) at 1100 Hrs PST at the address given below. The meeting may be attended online via web-link on request by emailing PTC at the address below. Terms and Conditions mentioned in the Prequalification Document shall be binding on the participating firms/manufacturers. Only Prequalified firms/manufacturers shall be invited to submit technical and financial bids in accordance with the Punjab Procurement Rules, 2014 (as amended from time to time). 
